Theory & Understanding

During the 2023-24 School Year all Grade K-9 teachers received PD in this area. All new staff in these grades received the PD this year.

Writing

All ELA teachers in Grades 1-12 participated in PD on writing rubrics and assessment.

Implementation & Integration

All Grade 4-9 teachers received PD and coaching on moving from theory to practical instructional strategies.


Data Collection

All students, grades K-9 were assessed using Diagnostic tests to determine gaps and deficiencies to inform instruction.

NUMERACY AT THE FOREFRONT

Expertise & Knowledge

All K-6 teachers received professional development and coaching on planning for implementing the new curriculum in their classrooms.

Data Collection

Clearview is working with a Math Consultant, utilizing the MathMap website, to create and implement numeracy screeners to be used in September of each year. These will be tested this spring.

Collaboration & Communication

All Mathematics teachers in Clearview had the opportunity to collaborate and work together to understand and improve assessment of student work. Grade 7 & 8 Final exams were implemented to standardize division expectations. More final exams will be created over time.

NAVIGATING BILL 27

Preferred names & Pronoun Use

- Under 16 parental consent is required
- 16 and over parental notification is required

AB ED Approval

 Minister of Education must approve learning and teaching resources dealing primarily and explicitly with gender identity, sexual orientation or human sexuality. External educators must be approved by the Minister as well.

Parental Opt-in

- Where classroom content deals primarily and explicitly with human sexuality, gender identity and sexual orientation parents must be notified and OPT-IN for this instruction
 - 30 days notice
 - o sufficient info for an informed decision
 - opt-in for all or part of instruction

At-Home Learning

- We must develop publicly available policy related to any shifts to at-home learning
- Considerations:
 - use of other facilities
 - rationale/criteria for shifting to athome learning
 - how will learning continue
